 6. No complaints or applications will be accepted after 4:00 PM on 19th January 2025.
 7. As per Section 7 of PMDC regulations 2023, candidates with less than 60% marks in HSSC/equivalent or less than 55% in MDCAT 2023 & 2024 are ineligible for admission to MBBS. Similarly, candidates with less than 50% marks in MDCAT 2023 & 2024 are ineligible for admission to BDS.
 8. Remarks mentioned against a candidate in one category i.e, OPEN MERIT will be applicable to other relevant categories like General Self Finance etc.
