Centralized Admission in MBBS/BDS Public Sector Medical/Dental Colleges of Khyber Pakhtunkhwa session 2021-22

1. Mere figuring in this order of merit shall not confer any right of admission on the candidate if he/she is otherwise found ineligible on detection of any error/mistake/fraud/misrepresentation at any stage of admissions.
2. Candidates can register complaints online at <https://cas.kmu.edu.pk/complaint.php> for any error, omission, lapse, mistake, fraud or misrepresentation in this list by Monday 31st January, 2022 (before 05:00 pm). Candidate can only submit complaint from his/her registered cnic no.(entered during account creation on online portal <https://cas.kmu.edu.pk>) and must attach a documentary proof (result card, etc.) In support of his/her claim, otherwise the complaint shall be rejected. Complaints in hard copy will not be entertained and there is no need to visit the university for this purpose.
3. For uploading deficiencies mentioned against candidates in provisional merit lists, candidates are required to login to <https://cas.kmu.edu.pk> using their cnic no. And password.
4. No complaint / application shall be entertained, received after 05:00 pm on 31st January, 2022.
5. Candidates must ensure corrected order of colleges' priorities till 31st January 2022, which will be used for automatic placement in case of no interviews due to covid 19 restrictions imposed by government.
6. Candidates with less than 65% marks in HSSC/ equivalent or NMDCAT (137/210) are not eligible for admission as per PMC regulations.
